VOLUNTARY SURRENDER OF LICENSE AFFIDAVIT

Marc Baer, being duly sworn, deposes and says:

1. I am over the age of majority and understand the obligations of an oath.
2. I make this affidavit on the basis of personal knowledge.
3. I am licensed by the Department of Public Health (hereinafter "the Department") to practice podiatric medicine. I presently hold license number P00326.
4. I hereby voluntarily surrender my license to practice podiatric medicine to the Department. This voluntary surrender shall become effective on October 1, 1998.
5. From the date I execute this affidavit until the effective date, I agree that I shall not engage in the clinical practice of podiatry, either in my own practice or for another medical practice. Failure to abide by this agreement shall result in all allegations contained in Petition Number 961218-019-013 being deemed admitted.
6. I understand and agree that if I seek a new license or to reinstate my license at any time in the future, the allegations contained in Petition Number 961218-019-013 shall be deemed true. I further understand that any such application must be made to the Department which shall have absolute discretion as to whether said license shall be issued or reinstated and, if so, whether said license shall be subject to conditions. Except as heretofore mentioned, this document does not otherwise constitute any admission of wrongdoing.
7. I hereby waive any right to a hearing I may have regarding any request that my license be reinstated or that a new license be issued and also waive any right that I may have to appeal or otherwise challenge the disposition of any such request.
8. I understand and agree that this affidavit and the case file in Petition Number 961218-019-013 are public documents, and I am executing this affidavit in settlement of the allegations contained in the above-referenced petition, without admitting the truth of said allegations.
9. I understand that this surrender of my license is a reportable event and is public information.


