CONSENT ORDER

IN THE MATTER OF

LINDA NORTON

WHEREAS, Linda ~~Norton~~, hairdresser, of Essex, Connecticut has been issued license No. 21927, to practice as a hairdresser by the Department of Health Services pursuant to Chapter 387 of the General Statutes of Connecticut, as amended; and

WHEREAS, Linda Norton hereby acknowledges and admits that she:

1. Is the owner of Essex Plaza Beauty Salon, a hairdressing salon in Essex, Connecticut.
2. In her capacity as owner, has advertised pedicure services at said salon on or about July 26, 1983;
3. Recognizes that the providing or performing of such pedicure services by hairdressers or manicurists or other persons not properly licensed to do so is a violation of the provisions of §20-263 of the General Statutes of Connecticut.


NOW THEREFORE, pursuant to §19a-17 and §20-263 of the General Statutes of Connecticut, as amended, Linda Norton hereby stipulates and agrees to the following:

1. That she will immediately cease and desist from promoting, from providing and from performing or permitting to be performed pedicure services by persons not properly licensed to do so at her


hairdressing salon in Essex and at any other location that she owns, operates, or manages in the State of Connecticut.

2. That she will immediately cease and desist from promoting, from providing and from performing pedicures at her hairdressing salon in Essex and at any other location that she owns, operates, manages or is employed in the State of Connecticut.
3. That she understands that notice of this Consent Order may be disseminated to the licensing bodies of other states.
4. That she understands that this Consent Order is not subject to reconsideration or judicial review under any form or in any forum. Further, it is not subject to appeal under the provisions of Chapter 387 and Chapter 54 of the General Statutes of Connecticut.
5. That she understands that she has the right to consult with an attorney prior to signing this document.

I hereby affix my signature, agreeing and admitting to the above, and declare this to be an act performed of my own free will.




