**VOLUNTARY AGREEMENT NOT TO RENEW OR REINSTATE LICENSE**

R. Douglas Mackey, being duly sworn, deposes and says:

1. I am over the age of majority and understand the obligations of an oath.
2. I make this affidavit on the basis of personal knowledge.
3. I was licensed by the Department of Public Health (hereinafter "the Department") to practice subsurface sewage installation and/or cleaning. I held license number 001059.
4. I hereby voluntarily agree not to renew or reinstate my license to practice subsurface sewage installation and/or cleaning to the Department.
5. So long as I am not licensed under Chapter 393a, I agree not to hold and/or purchase any financial share, percentage, allotment, stake, or part and/or take any other interest in any subsurface sewage installation and/or cleaning company or business in the State of Connecticut. In addition, so long as I am not licensed under Chapter 393a, I agree not to assume any position with a subsurface sewage installation or any other company required to employ an individual who is licensed pursuant to Chapter 393a, either voluntarily or for remuneration. If I acquire any interest in a subsurface sewage installation or cleaning company in Connecticut, by virtue of interests which predate this agreement, I shall immediately notify the Department of the vesting of such interest. Further, I agree to liquidate and divest myself of such interest within forty-five (45) days of receipt of such an interest, or such other time as the Department and R. Douglas Mackey mutually agree, provided that the sale of such interest shall be completed no later than six months from the vesting date. In liquidating and/or divesting such an interest, I agree not to transfer, sell, bequeath, devise, gift, grant or in anyway convey any such interest to my wife, parents, mother-in-law, father-in-law, children (natural or other) or siblings.
6. I understand and agree that if I seek a new license pursuant to Chapter 393a, or to reinstate my license at any time in the future, the allegations contained in Petition Number 950703-033-002 shall be deemed true. I further understand that any such application must be made to the Department which shall have absolute discretion as to whether said license shall be issued or reinstated and, if so, whether said license shall be subject to conditions.

- 7. I hereby waive any right to a hearing I may have regarding any request that my license be reinstated or that a new license be issued and also waive any right that I may have to appeal or otherwise challenge the disposition of any such request.
- 8. I understand and agree that this affidavit and the case file in Petition Number 950703-033-002 are public documents, and while admitting no guilt or wrongdoing, I am executing this affidavit in an expedient and economical manner for the purposes of settlement of the allegations contained in the above-referenced petition.
- 9. I understand that this agreement not to renew or reinstate my license is a reportable event and is public information.
- 10. I understand that, upon execution of this document by the Department, the Department will move to withdraw the Statement of Charges in Petition No. 950703-033-002. I understand that this document is not effective unless and until the Department has executed it, and the Hearing Officer either grants the Department's Motion to Withdraw or the charges are dismissed.
- 11. I understand that I have the right to consult with an attorney prior to signing this affidavit.
