CONSENT ORDER

WHEREAS, Anthony Sylvester of Hebron, Connecticut has been issued license number I-1463 to install subsurface sewage disposal systems by the Department of Health Services pursuant to Chapter 393a of the General Statutes of Connecticut, as amended; and

WHEREAS, Anthony Sylvester hereby admits and acknowledges that:

1. On or about 14 May 1985 he failed to obtain the proper permit, prior to repairing a septic system on property owned by the Pettengills in Hebron, Connecticut.
2. He failed to have said installation inspected or approved by the town sanitarian.
3. By his actions described in 1. and 2. above has violated the provisions of §20-341f of the General Statutes of Connecticut and §19-13-B103e of the Public Health Code by failing to conform to the accepted standards of the subsurface sewage disposal system installers profession.

NOW THEREFORE, pursuant to §19a-17 and §20-341f of the Connecticut General Statutes, as amended, Anthony Sylvester hereby stipulates and agrees to the following:


1. That he waives his right to a hearing on the merits of this matter.

2. That he is hereby assessed a civil penalty of \$50.00 for failing to comply with the provisions of §20-341f of the General Statutes of Connecticut. Said penalty is to be paid to the Treasurer, State of Connecticut and forwarded to the Department of Health Services, Public Health Hearing Office, 150 Washington Street, Hartford, Connecticut 06106. Payment of the aforementioned fine shall be by certified check.
3. That his license number I-1463 to practice as a subsurface sewage installer is suspended for a period of three months.
4. That said suspension shall be stayed immediately, and he will be placed on probation for the period of three months, conditioned on the following terms of probation:
 - a. he shall obtain proper permits prior to installing septic systems in all future installations;
 - b. he shall ensure proper inspection or approval by town authorities of all septic system installations.
5. That violation of any of the conditions listed in 4.a. through 4.b., inclusive, will result in the summary suspension of his license by the Department of Health Services.
6. That subject to satisfactory completion of the terms of probation his license to practice as a subsurface sewage installer in the State of Connecticut shall be fully restored.
7. That he understands that this Consent Order is a matter of public record and may be disseminated to other states.
8. That he understands that this Consent Order may be considered as evidence of the above admitted violations in any proceeding brought by the Commissioner of the Department of Health Services.

(1) in which his compliance with this same order is at issue, (2) in which is compliance with §20-341f of the Connecticut General Statutes, as amended, is at issue.


- 9. That he understands that this Consent Order is not subject to reconsideration of judicial review under any form or in any forum. Further it is not subject to appeal under the provisions of Chapter 54 or Chapter 368a of the Connecticut General Statutes, provided that this stipulation shall not deprive him of any other rights that he may have under the laws of the State of Connecticut or of the United States.
- 10. That he has consulted with an attorney prior to signing this document.
- 11. That this Consent Order will be effective the first day of the next month after which the seal of the last signatory is affixed to this document.

I, Anthony Sylvester, have read the above Consent Order, and I agree and admit to the terms and allegations set forth therein. I further declare the execution of this Consent Order to be my free act and deed.




