VOLUNTARY AGREEMENT NOT TO RENEW OR REINSTATE LICENSE

Joseph P. Zichichi, Member and General Manager of Southern Connecticut Restoration, L.L.C., being duly sworn, deposes and says:

1. I am over the age of majority and understand the obligations of an oath.
2. I make this affidavit on the basis of personal knowledge.
3. I am the Member and General Manager of Southern Connecticut Restoration, L.L.C. and I represent and warrant that I am fully authorized to bind said limited liability company. I hereby stipulate and agree to bind Southern Connecticut Restoration, L.L.C. to the terms set forth in this affidavit.
4. Southern Connecticut Restoration, L.L.C. was licensed by the Department of Public Health (hereinafter "the Department") to practice as an asbestos contractor. Southern Connecticut Restoration, L.L.C. held license number 000595 which lapsed due to nonrenewal on September 30, 2012.
5. I hereby voluntarily agree not to renew or reinstate the license of Southern Connecticut Restoration, L.L.C. to practice as an asbestos contractor in the State of Connecticut.
6. I understand and agree that if Southern Connecticut Restoration, L.L.C. seeks a new license or to reinstate its license at any time in the future, the allegations contained in Petition Numbers 2012-2, 2012-3 and 2012-4 shall be deemed true. I further understand that any such application must be made to the Department which shall have absolute discretion, as to whether said license shall be issued or reinstated and, if so, whether said license shall be subject to conditions.
7. I hereby waive any right to a hearing Southern Connecticut Restoration, L.L.C. may have regarding any request that its license be reinstated or that a new license be issued and also waive any right that Southern Connecticut Restoration, L.L.C. may have to appeal or otherwise challenge the disposition of any such request.
8. I understand and agree that this affidavit and the case files in Petition Numbers 2012-2, 2012-3 and 2012-4 are public documents, and I am executing this affidavit and agreeing to


bind Southern Connecticut Restoration, L.L.C. to the terms set forth in this affidavit in settlement of the allegations contained in the above-referenced petitions.

- 9. I understand that this agreement not to renew or reinstate the license of Southern Connecticut Restoration, L.L.C. is public information.
- 10. I understand that, upon execution of this document by the Department, the Department will present this document to the Commissioner of the Department or her designee and will move to withdraw the Statement of Charges in Petition Nos. 2012-2, 2012-3 and 2012-4. I understand that this document is not effective unless and until the Department has executed it, and the Commissioner of the Department or her designee either grants the Department's Motion to Withdraw or the charges are dismissed.
- 11. I understand that I have the right to consult with an attorney prior to signing this affidavit.
- 12. I understand that the execution of this document has no bearing on any criminal liability without the written consent of the Director of the Medicaid Fraud Control Unit or the Bureau Chief of the Division of Criminal Justice's Statewide Prosecution Bureau.
- 13. I understand that the purpose of this agreement is to resolve the pending matters against the asbestos contractor license of Southern Connecticut Restoration, L.L.C. and is not intended to affect any claim of civil liability that might be brought against me or Southern Connecticut Restoration, L.L.C.
